Announcement on the IDX Regarding the Schedule of HOKI Stock Split Implementation.

We hereby announce the schedule for the implementation of the HOKI stock split, as follows:

End of trading of shares with old nominal value in the Regular Market and Negotiated Market:

Wednesday, 17 February 2021.

Beginning of trading of shares with new nominal values in the Regular Market and Negotiation Market: Thursday, February 18, 2021.

Initial trading of shares with a new nominal value in the cash market: Monday, February 22, 2021.

Notes:

1. For Shareholders whose shares are in the collective custody of PT Kustodian Sentral Efek Indonesia ("KSEI"), the Stock Split will be implemented based on the Company's shares balance in each sub-securities account at the end of stock trading at the Indonesia Stock Exchange on February 19, 2021 (Recording Date). Then on February 22, 2021 (Payment Date), the shares resulting from the implementation of the Stock Split will be distributed through the securities sub account of each Shareholder.
2. For Shareholders whose shares have not been placed in the collective custody of KSEI or whose shares are still in scrip form, the application for a Stock Split can be made starting on February 22, 2021 by submitting the original Share Collective Certificate ("SKS") in the name of the Shareholder and a photocopy of proof of the Holder's identity.
